NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeast side of Sylvan Way in the City of Greenville, shown as lots 85, 86, 87, 88 and a portion of lot 89 on plat of Marshall Forest recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book H, Pages 133 and 134 and being more particularly described with reference to said plat as follows:

BEGINNING at an iron pin on the northeast side of Sylvan Way, said pin being at joint front corner of lots 84 and 85 and running along the northeast side of Sylvan Way N. 37-35 W. 25.2 feet to an iron pin joint front corner of lots 85 and 86; thence continuing along the northeast side of Sylvan Way N. 39-25 W. 95.44 feet to an iron pin in the front line of lot 89; thence turning and running through the northwesterly portion of lot 89 N. 45-20 E. 199.3 feet to an iron pin in the rear line of lot 89 on the southwest side of a 10' reservation for pipes and poles; thence along the southwest side of said 10' strip 5.54-40 E. 121.87 feet to an iron pin joint rear corner of lots 84 and 85; thence along the joint line of said lots S. 45-20 W. 232.7 feet to the point of beginning.
