WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Seventeen Thousand, Fifty and No/100-----(\$ 17,050.00) Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, Iying and being on the northeastern side of Strange Road, and known and designated as Lot No. 34, plat of Section II of a subdivision known as Sheffield Forest, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book BBB at Page 61, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northern side of Strange Road, jointifront corner of Lots 33 and 34, and running thence with the joint line of said lots, N. 18-33 E. 150 feet to an iron pin in the line of Lot 45; thence with the line of Lot 45 and continuing with the line of Lot 44, S. 71-27 E. 100 feet to an iron pin, joint rear corner of Lots 34 and 35; thence with the joint line of said lots, S. 18-33 W. 150 feet to an iron pin on the northern side of Strange Road; thence with Strange Road, N. 71-27 W. 100 feet to the beginning corner; being the same conveyed to me by Uldrick Construction Co., Edic. by deed of even date to be recorded herewith."
