And if it becomes necessary to collect this debt by suit or place it in the hands of an attorney for collection, I agree to pay Ten (10%) per cent. additional on the principal and interest then due as attorney's fees.

1. All that piece, parcel or lot of land in Oaklawn Township, Greenville County, State of South Carlina, and having the following metes and bounds: BEGINNING at an iron pin at center of W. M. Allen and Smith land, and running thence North 43-50 West 12-29 chains to iron pin; running thence North 2-00 West 5-00 chains to iron pin in Saluda River; thence running with the river as the line in a Southeasterly direction to a point at the corner of Pelzer Manufacturing Company property; running thence along Pelzer Manufacturing Company line South 89-00 West 19-18 chains to the beginning corner, and containing 24.12 acres, more or less, according to survey made November 6, 1950, by J. Coke Smith, and recorded in the R.M.C. Office for Greenville County. This is the same lot of land conveyed to J. R. Davis, mortgagor herein, by deed of W. M.
