All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, in Greenville Township, on the southeastern corner of the intersection of Otis Street and Elm Street, according to a plat prepared by C. M. Furman, Jr., Engineer, dated April 14, 1928, and having the following metes and bounds, to-wit:
