TO ALL WHOM THESE PRESENTS MAY CONCERN:

**John A. Pinckney, Jr. and Frank D. Pinckney**  
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Eighteen Thousand Five Hundred and No/100** - - - - - DOLLARS (\$ 18,500.00 ), with interest thereon at the rate of **5-3/4** per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is **25** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **on the western side of Altamont Road, near the City of Greenville and described as follows:**

**BEGINNING at an iron pin on the western side of Altamont Road, at the corner of property of Charles W. Burts, and running thence with the western side of Altamont Road, in a southerly direction 206 feet to a point; thence S. 62-30 W. 300 feet, more or less; thence N. 22-24 W. 206 feet to the corner of property of Charles W. Burts; thence with the line of said property, N. 62-30 E. 264.5 feet.**
