We, Daniel W. Howard & Beverly S. Howard

B. Dobson, according to survey and plat by H.L. Dunahoo, Surveyor, dated September 4, 1950, recorded in Plat Book T. pages 274-275. R.M.C. BEGINNING at a stake on south side of Grove Street, corner of Lots Nos. 41 and 42, and running thence along side of Grove Street S. 5-00 W. 185 feet to stake; thence along rear line of Lots Nos. 51, 52 and 53, S. 84-30 E. 210 feet to stake; thence along rear line of Lots Nos. 56 and 57, N. 16-00 W. 200 feet to south side of Grove Street; thence along said street, N. 84-30 W. 138 feet to the beginning corner.
