WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs
Township, on Creighton Street between the Village of Taylors and the City of Greenville, and being designated as Lot No. 12 of COLONIAL HILLS, Section #3, as shown on a plat thereof prepared by Piedmont Engineers & Architects, dated May 7, 1965 recorded in the R.N.G. Office for Greenville County in Plat Book BBB, page 91, and having, according to said plat, the following cow ses and distances:

BEGINNING at an iron pin on the western side of Creighton Street, joint front corner of Lots Nos. 11 and 12, and running thence along the joint line of said lots, N. 80-15 W. 150 feet to an iron pin at the joint rear corner of Lots Nos. 11 and 12; thence with the rear line of Lot No. 12, S. 9-45 W. 100 feet to an iron pin, joint rear corner of Lots Nos. 12 and 18; thence with the joint line of said lots, S.80-15 E. 150 feet to an iron pin on the western side of said Creighton Street, joint front corner of Lots Nos. 12 and 13; thence with the western side of said street, N. 9-45 E. 100 feet to the point of beginning.
