L. Craigo, his heirs and assigns forever,

ALL that piece, parcel or tract of land with buildings and improvements thereon situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as TRACT NO. 5 of the J. M. Richardson property as shown by plat recorded in the RMC Office for Greenville County in Plat Book F, at page 293 and described as follows:

BEGINNING at an iron pin at corner of Lots Nos. 4 and 5 on the Parkins Mill Road and running thence South 30-40 West 464 feet to an iron pin, corner of Tract No. 6; thence along line of Tract No. 6, South 59-45 East 569.1 feet to an iron pin on line of Williams property; running thence North 70-15 East 487 feet to an iron pin; running thence North 53-40 West 885.6 feet to the beginning corner and containing 7.10 acres.
