ALL that lot of land in Bates Township, Greenville County, State of South Carolina, on the northern side of White Horse Road, a short distance West of Greenville-Hendersonville Highway and being described as follows: BEGINNING at an iron pin corner of H. G. Duck and Henry Williams; thence S. 76 E.5.80 chains to center line of White Horse Road; thence with said road, S. $32\frac{1}{2}$ E. 1.60 chains to a point in White Horse Road; thence with said Road, N. 59 3/4 W. 5.52 chains to the beginning corner.

ALSO: ALL of that lot of land in Bates Township, Greenville County, South Carolina about 6 miles North of Travelers Rest on White Horse Road, and having the following metes and bounds according to survey by W. A. Hester, dated November 15, 1939, and being described as follows: BEGINNING at a point in the center line of White Horse Road; thence N. 77 W. 6.50 chains to an iron pin; thence S. 35 W. 1.58 chains to an iron pin; thence S. 77 E. 6.50 chains to center ## line of said road; thence along the center line of said road, N. 35 E. 1.58 chains to the point of Beginning.
