"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, being

located on the southwest side of Holland Road near Mauldin, and being shown as property of B.G. and Edith R. McKittrick as shown by plat thereof prepared by C.O. Riddle dated March 18, 1965, and having, according to said plat, the following metes and bounds, to-wit:
