ALL that lot of land with the buildings and improvements thereon situate on the northwest side of Old Indian Trail near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 66 of Block "C" on plat of Edwards Forest recorded in the RMC Office for Greenville County, South Carolina in Plat Book BB, Page 181 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwest side of Old Indian Trail at the joint front corner of Lots 65 and 66 and runs thence along the line of Lot 65 N. 32-50 W. 157.6 feet to an iron pin; thence S. 59-09 W. 133.3 feet to an iron pin on the northeast side of Bedford Road; thence along Bedford Road S. 32-44 E. 142.3 feet to an iron pin; thence with the curve of Bedford Road and Old Indian Trail (the chord being S. 80-37 E. 28.3 feet) to an iron pin on Old Indian Trail; thence along Old Indian Trail N. 57-05 E. 95.7 feet to an iron pin; thence still along Old Indian Trail N. 60-37 E. 17.4 feet to the beginning corner.

Old Indian Trail referred to above is now known as Indian Trail.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
