WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses to such proceedings, and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southwestern corner of Hillbrook Road and Shrevewood Drive, near the Town of Taylors, being shown as Lot No. 120, on plat of Brook Glenn Gardens, recorded in the RMC Office for Greenville County, S. C., in Plat Book "JJJ", at Page 85, and being further described as follows:

BEGINNING at an iron pin on the southwestern corner of Hillbrook Road and Shrevewood Drive, and running thence with the western side of said Shrevewood Drive, S. 14-42 E. 80 feet to an iron pin at comer of Lot No. 118; thence with line of said lot, S. 71-46 W. 103.5 feet to an iron pin at corner of Lot No. 119; thence with line of said lot, N. 22-37 W. 156.1 feet to an iron pin on Hillbrook Road; thence with the southern side of said Road, S. 85-30 E. 107 feet to an iron pin at comer of Shrevewood Drive; thence with the curve of the intersection, the chord of which is S. 50-06 E. 40.8 feet to the beginning corner.
