PARCEL ONE:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the northwestern side of Goldsmith Street, the southwestern side of Henry Street, and the northeastern side of David Street (also known as McKoy Street).
