A certain tract or parcel of land in the City of Charlotte, Mecklenburg County, North Carolina, described as follows:

BEGINNING at an iron pipe in the eastern right of way of South Tryon Street in the City of Charlotte, Mecklenburg County, North Carolina, and running thence South 55 deg. 28 min. East 418.07 feet to an old iron in the western margin of Yancey Road; thence the same course South 55 deg. 28 min. East 32.66 feet to a point in the center of Yancey Road; thence South 57 deg. 50 min. West 432.70 feet to a point in the center of Yancey Road; thence North
