MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, C. S. Willingham, of Greenville County

.. (hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, being known and designated as Lot 104 of a subdivision known as Colonial Hills, Section 3 as shown on plat thereof prepared by Piedmont Engineers and Architects, May 7, 1965 and recorded in the R. M. C. Office for Greenville County in Plat Book BBB at Page 91 and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southwestern side of Brushy Creek Road (now Taylors Road), the joint front corner of Lots 103 and 104 and running thence along the southwestern side of said road, S. 53-44 E. 105.0 feet to an iron pin; thence following the curvature of said road as it intersects with an unnamed street, the chord being S. 4-44 E. 32.8 feet to an iron pin on the northwestern side of said unnamed street; thence along the northwestern side of said unnamed street, S. 44-15 W. 161.0 feet to an iron pin at the corner of Lot 105; thence along the line of that lot, N. 62-01 W. 110.0 feet to an iron pin at the rear corner of Lot 103; thence along the line of that lot, N. 37-37 E. 200.1 feet to the begin ning corner;
