NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other end further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as Lot No. 38 on a plat of Rockwood Park, Section "A", made by Pickell & Pickell, Engineers, August 24, 1948 (as revised October 5, 1948), recorded in the RMC Office for Greenville County in Plat Book "S", at Pages 168 and 169, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwest side of Rockwood Drive, joint front corner Lots Nos. 38 and 39, which point is 176.3 feet northeast of the intersection of Rockwood Drive with the northeast side of Grey Street, and running thence along the line of Lot No. 39, N. 51-34 W. 175 feet; thence N. 38-26 E. 75 feet to an iron pin; thence along the line of Lot No. 37, S. 51-34 E. 175 feet to an iron pin on the northwest side of Rockwood Drive; thence along said drive, S. 38-26 W. 75 feet to the beginning corner.
