"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, located on the southwestern corner of the intersection of N. Warwick Road and Hathaway Circle and being known and designated as Lot No. 106 of Subdivision known as STRATFORD FOREST as shown by plat thereof prepared by Piedmont Engineers dated February 25, 1957, and recorded in Plat Book KK at Page 89 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Hathaway Circle at the joint front corner of Lots Nos. 105 and 106 and running thence S. 20-42 E. 269.2 feet to an iron pin; thence N. 83-20 E. 255.4 feet to an iron pin on the southwestern side of N. Warwick Road; thence with the southwestern side of N. Warwick Road, N. 23-39 W. 281 feet to an iron pin; thence with the curve of the intersection of N. Warwick Road and Hathaway Circle, the chord of which is N. 64-38 W. 45.2 feet to an iron pin on the southern side of Hathaway Circle; thence with the southern side of said Hathaway Circle, S. 74-23 W. 202.6 feet to an iron pin, the beginning corner.
