"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, situate on the southern side of Wpods Creek, being bounded on the south by lands now or formerly of Jonas Smith, on the north by lands now or formerly of Mae G. Turner, on the east by lands now or formerly of James Jennings, containing 29.6 acres, and having the following metes and bounds:
