Six per centum (6 %) per annum until paid, said principal and interest being payable
at the office of C. Douglas Wilson & Co.

in Greenville, South Carolina, or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of Sixty-two and 96/100-

----- Dollars (\$ 62.96), commencing on the first day of
October, 19 67, and continuing on the first day of each month thereafter until the principal and
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and
payable on the first day of xxxxxxxxxxxxxxxxxxxxxx . thirty-first day of August, 1997.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor
in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described
property situated in the county of Greenville
State of South Carolina;

All those pieces, parcels or lots of land situate, lying and being on the eastern side of
McNeese Drive near the City of Greenville, in the County of Greenville, State of South
Carolina and known and designated as Lot No. 10 and a portion of Lot No. 9 of a sub-
division known as Royal Oak, plat of which is recorded in the R.M.C. Office for Green-
ville County in Plat Book QQ at Page 117; also shown as the property of Caulie E. Gordon
by plat prepared by Carolina Engineering & Surveying Company recorded in Plat Book RRR
at Page 111; said lot having such metes and bounds as shown on said latter plat.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances
to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that
