"BEGINNING at an iron pin in the center of Oil Mill Road at its intersection with the eastern side of Old White Horse Road and running thence with the center of Oil Mill Road, N. 76-15 E. 852.4 feet to an iron pin; thence S. 1-12 E. 244 feet to an iron pin on the right-of-way of Southern Railway Company; thence along the right-of-way of Southern Railway Company, S. 89-30 W. 836.3 feet to a post on the eastern side of Old White Horse Road; thence with the eastern side of Old White Horse Road 55 feet to a point at the intersection of said road with Oil Mill Road, the point of beginning."

The undersigned Mortgagee, however, retains its lien in full force and effect over the balance of its mortgage referred to above.
