NOW, THEREFORE, this indenture witnesseth, that the Board of Church Extension of The Methodist Church does hereby grant, release, and quitclaim unto said Salem Methodist Church all that part of the mortgaged land as follows:

All that lot of land in the county of Greenville, state of South Carolina, just off the White Horse Road, (S. C. Highway 250) containing .60 of an acre as shown on plat made by Webb Surveying and Mapping Company June 1967 and having according to said plat, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin at the joint corner of property of the grantor and grantee which pin is 43.1 feet N. 12-27 E. from the northeast side of the right of way of White Horse Road (S. C. Highway 250); thence with the joint line of property of the grantor and grantee N. 12-27 E. 164 feet to an iron pin; thence turning and continuing with the joint line of said property S. 74-30 E. 375 feet to an iron pin; thence with a new line through property of the grantor S. 84-56 W. 315 feet to an iron pin; thence continuing S. 68-48 W. 88.4 feet to the beginning corner.
