Highway 250); thence with the joint line of property of the grantor and grantee N. 12-27 E. 164 feet to an iron pin; thence turning and continuing with the joint line of said property S. 74-30 E. 375 feet to an iron pin; thence with a new line through property of the grantor S. 84-56 W. 315 feet to an iron pin; thence continuing S. 68-48 W. 88.4 feet to the beginning corner.
