All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Bates Township in the vicinity of Locust Hill, being known and designated as Tract No. 4 according to a survey and plat of property of W.S. Bradley made by T.T. Dill, August 14, 1946, lying on the east side of the Greenville-Tigerville Road and described by metes and bounds, as follows, towit:

BEGINNING at an iron pin on the east side of the Greenville-Tigerville Road at the corner common to tracts Nos. 3 and 4 as shown on said plat and running thence along the dividing line between tracts Nos. 3 and 4, S 71-10 E 575 feet, more or less, to an iron pin; thence N 28-15 E 360.2 feet to an iron pin at the corner of Tract No. 5; thence along the dividing line between Tract Nos. 4 and 5, N 59-45 W 685 feet to a point in the center of said road; thence S 21-28 W with said road 236 feet; thence continuing with said road S 9-28 W 262.2 feet to the place of beginning and containing 5.9 acres.
