"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs
Township, on the south side of Carey Avenue in the City of Greer, and being shown as Lot No. 17 on a plat of the W.C. Smith property made by H. S. Brockman, Surveyor, dated May 25, 1936, which plat is recorded in the R.M.C. Office for Greenville County, and having the following courses and distances:

BEGINNING at a point on the southern edge of Carey Avenue on corner of Lot Nos. 14 and runs thence S. 29-54 W. 160.2 feet to a point on the rear line of Lot No. 16; thence S. 61-02 E. 64.2 feet to a point on the rear line of Lot No. 18; thence N. 27-22 E. 162.7 feet to a point on the southern edge of Carey Avenue; thence along said Carey Avenue, N. 63-04 W. 57 feet to the beginning corner.
