"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and "ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed increase, since of south Carolina, County of Greenville, Fairview Township, containing 2 acres, more or less, according to a plat prepared by T. H. Walker, Jr., Surveyor, deted April 27, 1968, fronting along the center of the Jenkins Bridge Road 309.2 feet, running along the joint line of other property of the Mortgagor 400.2 feet to the center of State Highway No. 418, fronting along the center of said 418 State Highway 168.4 feet; and running with the joint line of property of Ben W, Garrett from the center. of said State Highway No. 418 to the center of the said Jenkins Bridge Road a distance of 459.9 feet, and bounded by other lands of the Mortgagor, Jenkins Bridge Road, lands of Ben W.
