I, T. Dewitt Smith, Jr., of Greenville County

... (hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

therein specified in installments of One Hundred Thirty-Five and 71/100----(\$ 135.71 ) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 25 years after date; and

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, being known and designated as Lot No. 37 of Liberty Park, Map No. 2 as shown on plat thereof prepared by Dalton & Neves, Engineers, August 1958, and recorded in the R. M. C. Office for Greenville County in Plat Book MM, at Page 39 and having, according to said plat, the following metes and bounds, to-wit:
