Office for Greenville County. Specific reference is made to the aforementioned plat for the courses and distances of this lot.

ALSO, the right to the use, along with others who may be able to use the same, of the said drainage lot(which is 30 feet in width and which lies between Lots Nos. 44 and 43); and also for the purpose of beautifying the said drainage lot, but the beautifying thereof is not in anywise permitted to fill up the said drainage lot or to prevent the flow of water through the same for drainage purposes.
