That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, located near the Washington Baptist Church and west therefrom, lying northwesterly from the Saluda Cap Road and cornering in said road, and having the following courses and distances:

BEGINNING at an iron pin in the Saluda Gap Road, (iron pin on north bank thereof at 46 feet, and on line of Grover L. Brown), corner also with lands formerly owned by E. B. Caldwell, and runs themose along the line of Grover L. Brown, N. 12-30 E. exactly 320 feet to a stake at hollow black gum; thence a new straight line in a westerly direction exactly 8h feet to an iron pin; thence another new line in a seuthwesterly direction 213 feet to an iron pin on line of property formerly owned by E. B. Caldwell, which iron pin is exactly 51.5 feet S. 32-50 E. from old iron pin corner; thence along the old Caldwell line, S. 32-50 E. 252 feet to the beginning corner.
