MODIFICATION AGREEMENT INCREASING INTEREST RATE

TRAVELERS REST FEDERAL SAVINGS AND LOAN

This Agreement entered into this the 23rd day of August

1968, by and between Travelers Rest Federal Savings and Loan Association of
Travelers Rest, hereinafter referred to as the "Association", and

Eulas Young , hereinafter referred to as the "Obligor".

## WITHESSETH:

WHEREAS, the Association is the owner and holder of a promissory note dated
February 12, 1963, excuted by the obligor to it in the original sum of
\$ 10,500 , bearing interest at the rate of Six (6%)
per centum per annum, and secured by a first mortgage over property in
Travelers Rest, South Carolina, Lot 18, Loraine Drive, Meadowbrook,
Travelers Rest.

WHEREAS, the Obligor is delinquent in making his mortgage payments in accordance with the terms and conditions of said note and mortgage, which delinquency through the month of August, 19 68 amounts to the sum of \$ 267.52, plus \$ \_\_\_attorney fees, making a total of \$ 267.52 \_\_, and

WHEREAS, the Association has heretofore elected to declare the entire balance due and payable and foreclose its mortgage, but the obligor has agreed that if the Association would allow the obligor to place the delinquent mortgage account on a current basis through the month of <u>August</u>, 19 68that the Association, in consideration therefore, could increase the interest rate on said loan to the rate of <u>seven</u> (7%) per centum per annum which the Association has agreed to do.

NOW, THEREFORE, after payment by the Obligor totaling \$ 267.52 as referred to above, the current mortgage balance amounts to \$ 8,852.85 , together with interest on said amount as of Aug. 23, 19 68, at the rate of Six (6%) per centum per annum: and it is hereby agreed by the undersigned parties that the interest rate on said balance is hereby changed to Seven (7%) per centum per annum from September 1 , 19 68 forward.

IT IS FURTHER AGREED that said mortgage balance shall be paid at the rate of \$80.90 per month, beginning September 1 , 1968, with payments applied first to interest at the rate of Seven (7%) per centum per annum and then to the remaining principal balance due from month to month. It is agreed that with the exception of the change in interest rate and monthly payments, that all other terms and conditions of the note and mortgage shall remain unaffected.

This Agreement shall bind jointly and severally the heirs, executors, administrators, successors, and assigns of the Association and the Obligor, respectively.
