"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

All that piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, on the southwestern side of Augusta Road and being known and designated as Lot No. 10 on plat of property of G. L. Walker recorded in the R. M. C. Office for Greenville County in Plat Book "H", at Page 18, and having, according to said plat, the following metes and bounds, to-wit:
