**Know all Men by these Presents, That National Division of the Board of Missions of The Methodist Church,** a New York corporation, (whose former names were (a) Division of National Missions of the Board of Missions of the Methodist Church and (b) Division of Home Missions and Church Extension of the Board of Missions and Church Extension of the Methodist Church), successor by merger to the Board of Home Missions and Church Extension of the Methodist Episcopal Church, a Pennsylvania corporation, (whose name was formerly Board of Church Extension of the Methodist Episcopal Church), in consideration of the sum of One dollar, to it in hand paid by the Bank of Greer

of Greer, South Carolina, the receipt whereof is hereby acknowledged, has covenanted, promised and agreed, and does hereby for itself, its successors and assigns, covenant, promise and agree with the said the Bank of Greer

of Greer, South Carolina, its successors and assigns, that the lien of the Mortgage executed by the Monaghan Methodist Church, Now Piedmont Park Methodist Church of Greenville, South Carolina, dated April 19th 1947, for Two Thousand (\$2,000.00)

Dollars, and recorded April 28th 1947, in Book No. 362 of Mortgages, page 148, also the lien of the Mortgage dated 19 Dollars, and recorded 19, in Book No. 19 of Mortgages, page 19, and also the lien of the Mortgage dated 19, for 19 Dollars, and recorded 19, in Book No. 19 of Mortgages, page 19, shall be postponed in favor of and made subsequent to a lien of a certain Mortgage given and executed by the above named Piedmont Park Methodist Church of Greenville, South Carolina

to Bank of Greer to secure the payment of the sum of Sixty Thousand (\$60,000.00) Dollars, covering the following described real estate, lying and being situate in the County of Greenville and State of South Carolina to wit:

All that piece, parcel or lot of land in Chicks Springs Township, Greenville County, State of South Carolina, on Old Rutherford Road near Paris School.

BEGINNING at an iron pin corner of Old Rutherford Road and Cason Ave. and running thence with Old Rutherford Road N. 20 E. 196 ft. to iron pin; thence S. 42 E. 96 ft. to iron pin on Cason Ave., thence with Cason Ave. S. 49 W. 169 ft. to point of beginning, this lot being of triangle shape.

And it is hereby agreed that the said Postponement of Lien shall have the same force and effect as if the above-in-part recited Mortgage, or Mortgages, in favor of **National Division of the Board of Missions of The Methodist Church** had been entered upon the records in the office for the recording of Deeds, etc., of Greenville County aforesaid, on a day subsequent to the day of entry for record in the office, aforesaid of the said Mortgage for the sum of Sixty Thousand Dollars.
