(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ----- Twenty-four Thousand Nine Hundred and no/100----- DOLLARS (\$24,900.00---), with interest thereon at the rate of ~~10%~~ per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is twenty-five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Merrifield Drive near the City of Greenville, being shown as Lot No. 31 on plat of Merrifield Park recorded in Plat Book 000 at page 177, and more fully described as follows:

Beginning at an iron pin on the western side of Merrifield Drive at corner of Lot 32 and running thence with the western side of said lot, S 34-18 E 128.5 feet to an iron pin in line of lot designated "Ed High"; thence with line of said lot, N 69-22 W 28.3 feet and S 20-38 W 183.7 feet to an iron pin at corner of Lot 34; thence with line of Lots 34 and 33, N 24-26 W 213.9 feet to an iron pin at corner of Lot 32; thence with line of said lot, N 55-42 E 130 feet to the beginning corner.

Being the same property conveyed to the mortgagor by Deed Book 846 at page 583.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
