Robert R. Duvall and Shirley E. Duvall

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of - - - - - FIFTEEN THOUSAND AND NO/100THS- - - - - DOLLARS (\$ 15,000.00 ), with interest thereon at the rate ~~10% per annum~~ as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is fifteen years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Pine Ridge Drive, in Gantt Township, being shown and designated as Lot 28 of Section 2 on plat of Fresh Meadow Farms recorded in Plat Book S at page 61 and also shown on plat recorded in Plat Book SS at page 196, and being more particularly described as follows:

BEGINNING at a pin on the eastern side of Pine Ridge Drive at the joint front corner of Lots 27 and 28 and running thence with the line of Lot 27, N. 73-13 E. 252.3 feet to pin; thence N. 6-56 W. 277.1 feet to pin at rear corner of Lot 29; thence with the line of Lot 29, S. 38-31 W. 388.3 feet to pin on Pine Ridge Drive; thence with the eastern side of Pine Ridge Drive, S. 38-23 E. 55 feet to the beginning corner.

This being the same property conveyed to the Mortgagors herein by deed recorded in Deed Book 803 at page 575.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
