TO ALL WHOM THESE PRESENTS MAY CONCERN:

W. N. Leslie, Inc. -----(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Eighteen Thousand and No/100 -----  
DOLLARS (\$ 18,000.00 -----), with interest thereon from date at the rate of Seven and Three-fourths per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the northwestern side of Drewry Road near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 12 of a subdivision known as Avondale Forest, Section 2, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book BBB at Page 36; and according to said plat has the following metes and bounds, to-wit:
