11. That in the event this mortgage should be foreclosed, the Mortgagor expressly waives the benefits of Sections 45-88 through 45-961 of the 1962 Code of Laws of South Carolina, as amended, or any other appraisament laws.

- That should the Mortgagor prepay a portion of the indebtedness secured by this mortgage and subsequently fall

Should any legal proceedings instituted for the foreclosure of this mortgage, or should the Mortgage become a party to any suit involving this Mortgage or the title to the premise described herein, or should the debt secured hereby or any part thereof be placed in the hands an attorney at law for collection by suit or otherwise, all costs and expenses incurred by the Mortgage, and a reasonable attorney's fee, shall thereupon become due and payable immediately or on demand, at the option of the Mortgage, as a part of the debt secured thereby, and may be recovered and collected hereunder.

It is further agreed that the covenants herein contained shall bind, and the benefits and advantages shall inure to, the respective heirs, executors, administrators, successors, and assigns of the parties hereto. Wherever used, the singular shall include the plural, the plural the singular, and the use of any gender shall be applicable to all genders.
