Bill of the property of S. C. Beattie Estate and containing 1.20 acres and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on Midway Road at the joint front corner of a tract containing 2.00 acres and the tract herein conveyed and running thence South 30-00 East \$17.1\$ feet to an iron pin; running thence South \$5-15 West \$15.3\$ feet to an iron pin; running thence North \$42-21\$ West \$127.1\$ feet to an iron pin on Midway Road; running thence along Midway Road, North \$47-37\$ East \$131.9\$ feet to the beginning corner.
