"All that certain piece, parcel or but of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of... Greenville, on the West side of Sunset Drive, near Chick Springs, and being Lot #16 of GROVELAND DELL, according to survey and plat recorded in Plat Book BBB, Page 73, R. M. C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the west side of Sunset Drive, corner of Lots Nos. 15 and 16, and running thence along said Drive, S. 7-46 W. 100 feet to an iron pin, corner of Lot #17; thence M. 80-14 W. 180 feet to Lick Creek (iron pin back on bank); thence up the creek as the line to the corner of Lot #15, the surveyed line being N. 28-10 W. 110 feet to an iron pin on the bank of the creek; thence along the line of Lot #15, S. 77-44 E. 225 feet to an iron pin on the west side of Sunset Drive, the beginning corner.
