BEGINNING at an iron pin in the North Carlina-South Carolina State line at the northwestern corner of F. B. Edwards' property, said point being also north 86 degrees 45 minutes west 63.7 feet from a power pole on said State Line, and running thence south 25 degrees 17 minutes west 52 feet to an iron pin; thence north 24 degrees 48 minutes west to an iron pin on the North Carolina-South Carolina State Line; thence with said State Line south 86 degrees 45 minutes east 243.5 feet to the beginning.
