NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollan (\$3.00) to the Mortgagoe in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, shuate, bying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being triangular in shape, and being bounded on the northwest by Wade Hampton Boulevard (U. S. Highway 29), and on the East by South Carolina Highway No. 291, and on the southwest by property now or formerly of Greenville Petroleum Company and having, according to a plat prepared by Piedmont Engineering Service dated April 16, 1963, and revised July 30, 1964, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southeastern side of Wade Hampton Boulevard, in the right of way thereof and at the joint corner of property now or formerly of Greenville Petroleum Company and running thence with the right of way of said Wade Hampton Boulevard, N. 46-12-15 E. 8 feet to an iron pin; thence continuing with the right of way of said Boulevard, N. 44-55-45 E. 270 feet to an iron pin; thence S. 46-50 E. 66.8 feet to an iron pin on the western side of the right of way of S. C. Highway 291; thence with the right of way of said Highway, S. 1-48-30 W. 300.2 feet to an iron pin; thence S. 41-48-30 W. 67.5 feet to an iron pin in the line of property now or formerly of Greenville Petroleum Company; thence with the line of said property, N. 43-47-45 W. 275.7 feet to the point of beginning.

ALSO: All the fixtures, furnishings, furniture, equipment and all other personal property now located or to be located on the premises during the term of the loan for the operation of the restaurant.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way inclient or appertations, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
