NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indibted to the Mortgagor at any time for advances made to or for his account by the Mortgagor, and also in condidaration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hareby acknowledged, has grant objusted, beginned, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns:

ALL that certain piece, parcel, or lot of land, with all the improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, being known and designated as all of Lots 20 and fifteen (15) feet of the Southeastern portion of Lot 19 of a subdivision known as East Lake as shown on plat thereof being recorded in the RMC office for Greenville County, in Plat Book G, at page 229, and having, according to said plat, the following metes and bounds, to-wit: BECINNIN at a point on the Northeastern side of East Circle Avenue, which point is 15 feet Morthwest of the joint corner Lots 19 and 20, running thence with Bast Circle Avenue South 52-45 East 75 Foot to an iron pin; joint corner Lots 20 and 2F; thence with the joint line of said lots North 37-15 East 156.2 feet to an iron pin at the joint rear corner lots 21 and 20; thence North 53-22 West 75 feet to a point in the rear line of Lot 29; thence with a new line through lot 19 South 37-15 West approximately 155.3 feet to the point of BENGNING.
