"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing twenty-four and 25/100 acres more or less, having the following metes and bounds:

Beginning at an iron pin at southeast corner of Arantocschargearch country property now or formerly owned by Lillie B. & H. A. Lindsey and running thence N. 83-00 W. 1655 feet on D. O. Leslie line to iron pin by branch; thence up the meanders of branch as line N. 43-08 E. 1044.7 feet to iron pin at spring; thence N. 84-00 E. 600 feet to iron pin; thence N. 87-52 E. 295 feet to iron pin (Dogwood corner); thence S. 3-20 E. 887.5 feet to beginning corner.
