To All Whom These Presents May Concern: I, Timothy L. Howell, - - -

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of - - - -

DOLLARS (\$12,000.00), with interest thereon from date at the rate of eight (8%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the east side of State Highway No. 14, near Berry's Mill and McCools Beaver Dam Creek, about six (6) miles north from the City of Greer, and being a portion of a 20.1 acre tract, according to a survey and plat of the property of Pauline A. Dobbins and Boyce C. Dobbins by Robert Jordan, Registered Surveyor, dated May 3, 1967, and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at an iron pin in S. C. Highway No. 14, and running thence N. 80-24 E. 244 feet to an iron pin; thence S. 58-05 E. 168 feet to an iron pin; thence S. 3-30 E. 225 feet, more or less, to an iron pin; thence S. 82-01 W. 384.5 feet to an iron pin in S. C. Highway No. 14; thence along and with S. C. Highway No. 14, N. 6-15 W. 350 feet, more or less, to the point of beginning.
