NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Stacey Drive being shown as lot no. 10 on a plat of Green Pastures Subdivision dated March 20, 1965, prepared by Carolina Engineering Company recorded in Plat Book III at page 133 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Stacey Drive at the south-western corner of lot no. 10 herein described and running thence N. 20-53 W. 150 feet to an iron pin; thence N. 69-07 E. 122.5 feet to an iron pin; thence S. 21-46 E. 125.1 feet to an iron pin; thence with the curvature of Stacey Drive, the chord being S. 23-41 W. 35.1 feet to an iron pin on the northern side of Stacey Drive; thence with said Drive S. 69-07 W. 100 feet to the point of beginning.

This is the sameproperty conveyed to the mortgagors by deed of Horace L. Mauldin to be recorded herewith.

The mortgagors agree that after the expiration of ten years from the date hereof, the mortgagee may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the mortgagors agree to pay the mortgagee as premium for such insurance one half of 1% of the principal balance then existing.
