NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, known and designated as Lot 16 of Spring Forest Estates, and being more particularly described, according to a Plat of C. O. Riddle, R.L.S., dated November, 1956, recorded in the R.M.C. Office for Greenville County in Plat Book KK, Page 117, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of a County Road, joint corner of Lot 15 and running thence N. 84-07 W., 328.4 ft. to an iron pin; thence N. 5-53 E., 342.3 ft. to an iron pin; thence S. 84-07 E., 300.4 ft. to an iron pin on the Western side of said Road; thence along said Road, S. 2-42 W., 186.8 ft. to an iron pin; thence continuing along said Road, S. 5-53 E., 158.5 ft. to an iron pin at the point of beginning.

This being the same property conveyed to the mortgagors by deed dated September 3, 1970, and recorded in the R.M.C. Office for Greenville County in Deed Book 898, Page 56.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hercinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever tawfully claiming the same or any part thereof.
