All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, on the western side of Grove Road and the southeastern side of Highway I-85. Also known as Church Street Extension in Greenville and having according to a plat thereof as recorded in the R.M.C.
