NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, percel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Caroline, County of Greenville, Fairview Township, Town of Fountain Inn, known and designated as Lot No. 13 on a Plat prepared by W. J. Riddle, Surveyor, March 28, 1952 and having according to said Plat, the following metes and bounds:

BEGINNING at an iron pin on New Street, N. 21-23 E., 80 feet to an iron pin, joint front corner with Lot No. 12; thence with the joint line of Lot No. 12, N. 68-37.W., 150 feet to an iron pin, back joint corner with Lot No. 12 on line of other land of Grantors; thence S. 21-23 W. 80 feet to an iron pin on line of Lot No. 14; thence with joint line of Lot No. 14, S. 68-37 E., 150 feet to an iron pin.
