"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, on the west side of Ridgewood Drive near the City of Greenville in Greenville County, South Carolina, being shown as Lot No. 20 on Plat of Woodland Hills recorded in the RMC Office for Greenville County, South Carolina, in Plat Book Y, Page 60, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of Ridgewood Drive at the joint front corner Lots 19 and 20 and runs thence along the line of Lot 19 S. 73-0 W. 140 feet to an iron pin; thence S. 8-28 E. 101.1 feet to an iron pin; thence along the line of Lot 21 N. 73-0 E. 155 feet to an iron pin on the west side of Ridgewood Drive; thence along Ridgewood Drive N. 17-0 W. 100 feet to the beginning corner.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully spixed of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
