NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

" ALL that certain piece or lot of land with-all improvements thereon situate, lying and being in the State of South Carolina, County of Greenville, Oaklawn Township and being part of the now or formerly Grady Lollis Home place and more particularly described by that certain survey and plat made by John C. Smith, Surveyor, March 25, 1968 as follows:

BEGINEING at a point in the center of Richie Road 320 feet from the Woodville Road and running thence N. 54-15 W. 236 feet to an iron pin; thence N. 35-45 E. 185 feet to an iron pin; thence S. 54-15 E. 236 feet to point in said road; thence along the center of road S. 35-45 W. 185 feet to the beginning corner and containing one acre, more or less: geing the same lot of land conveyed to Jimmy Ray Lollis and Cynthia Jane Lollis by deed recorded in Beed Book 895, at Page 531, Cynthia Jane Lollis having conveyed her interest to the Mortgagorby deed to be recorded herewith.
