"ALL that certain piece, percel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, located on Church Street and being shown on the County Block Book at 39-2-6 and being shown on the City Block Book at 39-2-6 and being shown on plat of property of C.-B. Myers made by Carolina Engineering & Surveying Company dated August 19, 1960, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on Church Street and running thence along Church Street, North 45-45 East 100 feet to an iron pin; running thence South 47-46 East 115.8 feet to an iron pin on Hilley Street; running thence along Hilley Street, South 42-47 West 100 feet to an iron pin; running thence North 47-41 West 121 feet to an iron pin, the beginning corner.
