"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Shelburne Road, being shown as Lot 126 on plat entitled "A re-Division of Lots 125 and 126 of Tully P. Babb Estate" recorded in Plat Book 4A at Page 17 in the R.M.C. Office for Greenville County, and having according to said plat the following metes and bounds:
